- Keep Excavated Soil (spoils) And Other Materials At Least 2 Feet (0.6 Meters) From Trench Edges.
- Know Where Underground Utilities Are Located Before Digging.
- Test For Atmospheric Hazards Such As Low Oxygen, Hazardous Fumes And Toxic Gases When > 4 Feet Deep.
- Inspect Trenches At The Start Of Each Shift.
